

**Wheeler Central Public School  
Safe Return Plan  
2024-2025**

The district plans to operate in a traditional learning environment during the 2024-2025 school year unless there is a state or federal mandate that requires school districts to implement the protocols listed below or if there is a COVID-19 outbreak. The district will consider a situation when 20% of the student/staff population has tested positive for COVID-19 an outbreak. If a COVID-19 outbreak were to occur, the district would look to implement some or all of the safety protocols listed below for a timeframe of five days. The district's Safe Return Plan may change as new guidance becomes available from the Nebraska Department of Education, the CDC, or other state and local public health entities.

### **Contact Tracing (Isolation & Quarantine)**

The district will follow the Isolation & Quarantine guidelines from both the CDC and the Loup Basin Health Department Public Health Solutions during the 2024-2025 school year and will comply with all privacy laws. Our local public health department will be contacted when the district becomes aware of a potential exposure requiring their assistance in contact tracing, and the district will assist the department in contacting close contacts. The district will use its website to publish the most current health department recommendations concerning quarantine and isolation. Students and staff who show symptoms of COVID will be encouraged to stay home. Sick leave policies and practices may need to be modified during an outbreak to accommodate this expectation.
