

## **October Meeting**

**October 14, 2024**

The Wheeler Central Board of Education Regular Board Meeting was held October 14, 2024. Chairperson Kasselder called the meeting to order at 7:01 p.m. and pointed out the location of the Open Meetings Act poster. The roll was called with the following present: Zach Wright, Drew Kasselder, Dennis Derner, Jessie Swick, and Andrew Smith. Swick made a motion, seconded by Wright, to excuse Adam Freouf. Roll call vote: Wright - aye, Smith - aye, Kasselder - aye, Swick - aye, Derner - aye. Motion carries. Also present were Dan Kluver, Makayla Reiter, and Andrea Pelster.

Smith made the motion to approve the consent agenda as presented. Seconded by Swick. Roll call vote: Wright - aye, Smith - aye, Kasselder - aye, Swick - aye, Derner - aye. Motion carries.

The pledge of allegiance was recited.

Chairperson Kasselder welcomed the visitors and opened the floor for public comment. No public comment was held at this time.
