

## **May Meeting**

**May 12, 2025**

The Wheeler Central Board of Education Regular Board Meeting was held May 12, 2025. Chairperson Swick called the meeting to order at 7:00 p.m. and pointed out the location of the Open Meetings Act poster. The roll was called with the following Board members present: Andrew Smith, Dennis Derner, Jessie Swick, Zach Wright, and Sydney McKay. Smith made a motion to excuse board member Drew Kasselder.
