

## **October Meeting**

**October 13, 2025**

The Wheeler Central Board of Education Regular Board Meeting was held October 13, 2025. Chairperson Swick called the meeting to order at 7:01 p.m. and pointed out the location of the Open Meetings Act poster. The roll was called with the following present: Zach Wright, Drew Kasselder, Dennis Derner, Jessie Swick, Sydney McKay and Andrew Smith. Smith made a motion to approve the addition of a bottle filler water fountain by the AG room and in the Old Gym. Seconded by McKay. Roll call vote: Derner - nay, McKay - aye, Wright - aye, Smith - aye, Kasselder - aye, and Swick - aye. Motion carried.

Kasselder made a motion to approve the Country Bliss Flooring bid of \$4,514.47 to replace the carpet in 2 classrooms. Seconded by McKay. Roll call vote: Derner - aye, McKay - aye, Wright - aye, Smith - aye, Kasselder - aye, and Swick - aye. Motion carried.
